#### Minutes of the 2023 Annual Meeting

The One Hundred and Nineteenth Annual Meeting of the Stockholders and Patrons of the Ludlow Cooperative Elevator Company was held Wednesday, August 23, 2023, at the Pueblo Lindo Event Center, Paxton, Illinois at 7:00 PM.

President Pat Quinlan called the meeting to order and introduced the Board of Directors and distinguished guests.

Secretary Ryan Vance presented the Notice of Meeting and Affidavit of Mailing. Being no objections, they were received and incorporated into the minutes.

President Quinlan presented the following to serve as members of the credentials committee:

Credential Committee Chairman Roger Gustafson presented his report of said committee.

Mr. Quinlan announced that legal notice of the meeting had been given, a quorum was present, and the meeting was now legally and lawfully convened and ready to transact business.


# Nominees for 2024-2025 Board of Directors In alphabetical order
